*Acceptable Applicant classification

A person (or nominee of) who acts in the course of external regulated business and is regulated under the laws of an Equivalent Jurisdiction.

A company listed on a recognised stock exchange or a wholly owned subsidiary of such a company.

Important notes

- ** Where possible Zurich will source the Certification of Incorporation independently.
- *** At least one of the authorised signatories which we have identified must sign the application form.
- **** A.Where the trustees are individual employees, we require name, address and date of birth. If not employees we require suitably certified ID and proof of address for each trustee.
- **** B. Full registered address of the settlor.

Certification guidance notes:

The suitable certifier should write the following relevant phrase including all information below on or with all certified documents:

"I certify that this document is a true copy of the original" and for documents containing a photo:

"I certify this to be a true copy document and the photo is a true likeness of the holder".

- Signature of certifier.
- Full name of certifier (in CAPITAL letters underneath the certifier's signature).
- · Position/job title.
- · Company name, address and telephone number.
- · Date.
- · Registration number (if applicable).
- The capacity of the certifier must be stated.

Suitable certifiers will fall into the following categories:

- A regulated introducer who is incorporated in or formed under the law of a country which is an equivalent jurisdiction.
- A notary public, lawyer, advocate or an embassy official (from the embassy of the country who issued the ID document).
- An accountant who must be a member of an institute or professional organisation.
- An authorised employee of the Zurich group.

Certification must be within 6 months of receipt
